What is the overall deductible?	\$1,000 individual / \$1,500 parent and child / \$1,500 parent and children / \$2,000 two person / \$2,000 family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes, immunizations.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
Are there other deductibles for specific services?	Yes, \$500 for infertility services. There are no other specific <u>deductibles</u> .	You must pay all of the costs for these services up to the specific <u>deductible</u> amount before this <u>plan</u> begins to pay for these services.

What is not included in the out-of-pocket limit?	<u>Premiums</u> , <u>copays</u> , infertility services, prescription drug services, <u>balance-billed</u> charges and health care this <u>plan</u> doesn't cover.
