<b>What is the overall deductible?</b>	<b>\$250</b> individual / <b>\$375</b> parent and child / <b>\$375</b> parent and children / <b>\$500</b> two person / <b>\$500</b> family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your deductible?</b>	Yes, <u>preventive care</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
<b>Are there other deductibles for specific services?</b>	Yes, <b>\$500</b> for medical infertility services. There are no other specific <u>deductibles</u> . <b>Will you pay less if you use a network provider?</b>	Yes. ### Does this plan provide Minimum Essential Coverage? Yes.
