•	Immediate-Release Opioids: BCBSND will require Prior Approval for opioid IR products if a patient meets a combination of the following conditions: <ul style="list-style-type: none"> ◦ Patient is new to opioid therapy ◦ Patient is using opioid therapy > 50 morphine milligram equivalents (MME) per day ◦ Duration of therapy is ≥7 days of therapy.
•	Extended-Release Opioids: BCBSND will require Prior Approval for Opioid ER products. Patients that are currently on an extended-release will be allowed continuation of therapy for the same agent. Dispensing limits are currently in place for all opioid ER products
